I, Mr. Hemant Shetye Partner of HS Associates, Practicing Company Secretaries, had been appointed as the Scrutinizer by the Board of Directors of Centenial Surgical Suture Limited vide Board Resolution dated Wednesday the February 19, 2020 pursuant to Section 108 and 110 of the Companies Act, 2013 read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014, to conduct the entire Postal Ballot process consisting of E-voting and the Postal Ballot forms received from the shareholders in respect of the resolutions mentioned in the notice of Postal Ballot dated Wednesday the February 19, 2020.


